

# Newton Ferrers and Noss Mayo WI Community Hall Trust

**We are running a 100 Club as a fundraiser for the hall renovation fund which needs to keep growing.**

## **What is a 100 club?**

- A 100 Club is a form of private lottery with a pre-set amount of numbered lottery tickets, e.g. 100 tickets/numbers for a 100 Club.
- Only persons over 16 may take part.
- More than one ticket may be purchased by any person. If all 100 numbers are sold a waiting list can be started.
- Each numbered ticket is then entered into a monthly draw and prizes are awarded.
- The prizes are cash with a first and a second prize each month paid by cheque.

## **How does it work?**

- Supporters of the WI Community Hall, pay £5 a month as a fixed subscription for a number/ticket. We prefer this to be in the form of a cheque for the year or half year or a monthly fee of £5. The amount will depend on when you join. Payment can be by cheque if paying for the year or half year. A standing order is preferred for a monthly subscription. (Forms to arrange this will be provided or it can be done through online or telephone banking)
- We will give 50% of the money collected each month as lottery prizes and the remainder to the hall renovation fund. The potential if all 100 tickets are sold is a profit of £250 per month to the hall and 2 prizes of £200 and £50.
- The draw would take place each month at a WI meeting. If all 100 numbers are not sold for any particular month, prizes will be 40% and 10% of takings for that month.
- Winners would be notified personally and a list of them posted on the hall notice board. We hope to print them in the parish mag and the Nose too –

The 100 Club started in January 2013 with first draw on February 5<sup>th</sup> at the WI meeting.

# Newton Ferrers and Noss Mayo WI Community Hall 100 Club

## Rules

1. Newton & Noss WI Community Hall Trust is registered with South Hams District Council under the Gambling Act 2005 – Small Society Lotteries
2. The lottery will be run in accordance with the Gambling Act 2005 and subsequent amendments.
3. All proceeds from the 100 Club, after prizes have been paid out, will be used by Newton Ferrers & Noss Mayo Community Hall Trust (Charity No: 1054164) for work to renovate the hall.
4. There is no limit on the number of tickets an individual can hold. Anyone can subscribe to the Newton & Noss WI Community Hall 100 Club. Tickets can be purchased throughout the year.
5. Persons under the age of 16 cannot buy or sell tickets.
6. Ticket numbers will be allocated sequentially as application forms are received.
7. Tickets will be priced at £5 each per monthly draw - £60 per annum (£30 per half year,).
8. **Payment will be by cheque, or standing order Made payable to:  
" Newton & Noss WI Community Hall 100 Club "**
9. Each draw will take place at 7.30pm at the WI meeting on the first Tuesday of each month. One of the Trustees or Angela Macpherson will oversee the draw. An independent person who does not belong to the 100 Club will witness each draw. **The first draw will take place on Tuesday 5th February 2012 at 7.30pm at Newton Ferrers and Noss Mayo WI meeting.**
11. **Prizes** will be allocated as a percentage of the month's proceeds from all fully paid tickets.
  - First prize 40%, second prize 10%,
  - Prizes will be rounded to the nearest whole Pound Sterling
  - Prizes will be paid out by cheque before the end of the respective month.
12. Angela Macpherson and Brenda Merritt, secretary of Newton Ferrers & Noss Mayo Community Hall Trust will administer the Club under the supervision of Alan Cooper, Chairman of the Trust.
15. The decision of the Newton & Noss WI Community Hall Trust shall be final in all matters requiring adjudication. Newton & Noss WI Community Hall Trust also have the power to amend or revoke these rules at their absolute discretion with such reasonable notice to the 100 Club members as is necessary.
